Contest Official Rules

**Eligibility:** No purchase or obligation necessary to participate and win. Registering contest participants must be members of Xplore Federal Credit Union. All registering participants must be 18 years of age or older at time of contest participation. Employees of XPLORE Federal Credit Union, their immediate families (spouses, parents, children and siblings, and each of their respective spouses), and members of the household of such individuals are not eligible to register for the contest

**How to Enter the Contest:** The Contest begins at 12:00 p.m. Central Time on Monday, October 18<sup>th</sup> 2021 and ends at 12:00 pm on Friday October 22<sup>nd</sup> 2021 ("Contest Period").

To participate, comment to the designated Xplore FCU Facebook post or Xplore FCU Instagram post about your favorite benefit of being a member of Xplore FCU. Entrants may enter on each platform one time during the Contest Period. Entries deemed inappropriate or unsuitable, in Sponsor's sole discretion will be disqualified. Each Entrant attests that he/she has made all those depicted in the Entry aware that he/she is submitting an Entry containing them in this Contest, and that all depicted have agreed that Entrant may submit such Entry. By entering, each Entrant understands that any Entry, in its entirety or any portion thereof, may (in Sponsor's sole discretion) be posted on the Website, broadcast on television and/or used in other Sponsor-selected media, and hereby grants all rights necessary to the Contest Entities, or any of them, to so post, broadcast and/or use such Entry or portion thereof.
